UNM College of Education Dean S. Hector Ochoa to address LWVCNM in December

UNM College of Education (COE) Dean S. Hector Ochoa will present “Changes in UNM College of Education to Address NM Educational Challenges” to the League of Women Voters of Central New Mexico during the December General Meeting on Thursday, December 10th, 11:45 am, at the MCM Elegante (2020 Menaul Blvd NE).

Dean Ochoa will discuss changes to UNM COE Teacher Education resulting from NM demographics and critical issues. The UNM COE includes five Departments and Programs:

- Educational Specialties
- Health, Exercise, and Sports Science
- Individual, Family, and Community Education
- Language, Literacy, and Sociocultural Studies, and
- Teacher Education, Educational Leadership, and Policy

UNM COE is currently among six Colleges for teachers of public education. NM Governor Susana Martinez had issued “Report Cards” to each of the six colleges 2014. The NM Public Education Department (PED) issued a November 18, 2015 Press Release “US Department of Education Approves NM’s Plan to Provide Every Child Access to Effective Teachers.” The NM PED statement further states that low income and minority students will have access to great teachers and the current equity gap will be eliminated.

The US DOE released the NM Equity Profile in the fall of 2014 and the NM PED indicated the equity gap exists in four areas:

- Recruiting and Retaining Effective Teachers
- Teacher Preparation
- Ensuring Teachers provide Culturally Relevant Instruction, and
- Teacher Mentorship and Professional Development

Dr. S. Hector Ochoa began his tenure as UNM COE Dean July 14, 2014. He previously served as Professor and Dean of the College of Education at the University of Texas Pan American. He earned a Bachelor’s degree in Psychology, a Masters of Education degree in Guidance and Counseling, and a PhD in School Psychology. His research focuses on bilingual psycho-educational assessment and educational programming issues pertaining to Hispanic students. He has conducted workshops on educational factors associated with culturally and linguistically diverse students. In addition, he served on a US DOE Expert Advisory Panel for the study of English language learners with special needs. Included among his publications is Assessing Culturally and Linguistically Diverse Students: A Practical Guide.
