The Legislative Education Study Committee (LESC) and the Legislature: Emerging Issues in New Mexico's K-12 Public Education System

Speaker: Dr. Pauline Rindone, LESL Director

Thursday, July 12 11:45 a.m. Luncheon Wyndham Hotel 2910 Yale Blvd. SE

At the May Convention the LWVNM agreed to review the LWVNM education position. Dr. Rindone's presentation will be a good kickoff event for the review of the position and will provide information on related issues of importance in the 2008 Legislative session.

The Legislative Education Study Committee was created in 1965 as a permanent committee of the New Mexico Legislature, authorized by statute to conduct a continuing study of all education in New Mexico, the laws governing such education and the policies and costs of the New Mexico educational system, recommend changes in laws relating to education, and make a full report of its findings and recommendations. The LESL is composed of 29 legislators (10 voting, 19 advisory) appointed to provide proportionate representation of both houses and political parties. Assisted by a permanent staff, the committee meets regularly during the interim between legislative sessions to study education

issues. To fulfill its statutory responsibilities, the LESL attempts to provide all legislators with objective information pertaining to New Mexico public schools as well as to state and national education trends.

Dr. Rindone has had 20 years of experience with the LESL. As director, she plans, develops, and coordinates the state's educational agenda, including public school finance for the LESL. She coordinates and oversees the Committee's continuing study of the laws and policies governing New Mexico's K-12 educational system and works with the committee in its development of recommendations of legislation to the New Mexico Legislature.

She holds a Ph.D. in Education Foundations, with emphasis on research and evaluation, from UNM. Her teaching and administrative experience in elementary, secondary, and post-secondary education provided a wide range of expertise in developing state educational policy. *Richard Mason*

President's Corner

Fifteen of us traveled to Las Cruces as LWV/ABC delegates to the State Convention May 18-20. The Las Cruces League did a wonderful job of putting on the convention, and everything went well. There were revisions made in state positions in health care, drug policy, legislative compensation and campaign finance and ethics reform. The convention adopted a position supporting the repeal of the death penalty and a statement saying that impacts on sustainability should be considered when adopting new positions. A new study on water supply and demand and a review of the state's education position were adopted. The Albuquerque League's proposed study on Fair Representation sailed through. A Budget Committee proposal to reduce the Per Member Payment to LWVNM by 1/3 was defeated by the assembly.

Our own program here at LWV/ABC will be affected by what was adopted at the state level, of course, so you can look forward to units on fair representation and water. The national organization has been conducting a study on immigration, and that will also be addressed this year in our units. Carolie Mullan, our regional liaison to the LWVUS Board, and leader of that study, attended the State Convention and delivered a report on it. In Directions to the Board it was requested that a program of revenue sharing from the state to the local Leagues be considered, and a committee is being appointed to do that.

Next month I will update you on the happenings at the LWVUS Council meeting in Washington, DC.

We've been doing a little work of our own in Albuquerque, and you should see the fruits of that labor in a few months. In the meantime, I hope you all enjoy the beautiful summer weather and whatever holidays you have planned. Our board will take a break in the month of July and be back at it again in August.

A Message from the Drug Policy Study Committee

Next meeting: Thursday, July 26, 1-3 p.m.

The Drug Policy position on treatment was changed at the annual meetings of both LWV/ABC and LWVNM. The new statement separates the concept of drug dependency and addiction. (Drug dependency is not addiction.)

The advent of many new powerful drugs to treat pain and the fear of addiction by consumers and healthcare professionals make it essential that we talk about what we have thought to be true and what has changed. The "War on Pain" is affected by the "War on Drugs." Federal drug policy regulates these new drugs as well as those prescribed in the past. Consumers' access to their use can be restricted.

Precise language and rational discussion are needed in talking about drug policy. Rational discussion is critical to create good public policy.

At the next Drug Policy Study Committee meeting (July, 26), the scope of the study and development of consensus questions about pain management will be discussed.

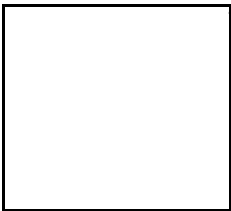
