## Key Issues in Energy and Natural Resources

**Speaker: Terry Brunner, State Director to U.S. Senator Jeff Bingaman,  
Chair of the Energy and Natural Resources Committee of the U.S. Senate.

For the last six years, Terry Brunner has served as the State Director to United States Senator Jeff Bingaman (D-NM) where he oversees the Senator's New Mexico activities and manages the Senator's five district offices. Prior to working for Senator Bingaman, Terry worked in local government as a Policy Analyst for the Santa Fe County Commission and assisted National Association of Counties President, Javier Gonzales. Mr. Brunner earned

his Bachelor's degree in Latin American Studies from the University of Arizona and his Master's in Latin American Studies from the University of New Mexico.

Terry will talk about Senator Bingaman's legislative priorities, especially in the area of energy and natural resources. As Chairman of the Energy and Natural Resources Committee of the U.S. Senate, the Senator will be a key player in determining U.S. policy in these crucial areas.

## President's Corner

In June I traveled to Washington, DC, for the LWVUS Council meeting. Council is held in the odd-numbered years, always in Washington, as opposed to Convention, which is held in even-numbered years in various locations around the country. Council is much smaller because it consists of just two voting delegates from each state League and members from Big City, Capital City and Inter-League Organizations. I attended as a Big City League member, and Cheryl Haaker and Kathy Campbell, LWVNM President, attended as the two delegates from New Mexico. There were 122 of us in attendance. The primary objective of Council is to pass the budgets for the next year. There were also reports on LWVUS projects, such as the Immigration Study and the Membership Recruitment Initiative.

I had attended one LWVUS convention previously but never a Council meeting. To be honest, I had mixed feelings about the experience. Cheryl will give you her impressions of the plenary session elsewhere in this issue. I will say that LWVUS President Mary Wilson did a fine job in running the plenary session smoothly and on time. There were a couple of excellent speakers, Eleanor Holmes Norton, non-voting U.S. Representative from the District of Columbia, and Ray Suarez of PBS, and a very good panel of experts on immigration.

From my perspective, the most beneficial aspect of this experience was the opportunity to meet and talk to members from other Leagues around the country. There was a networking session for local League presidents to exchange ideas and a panel discussion regarding the running of the League at all three levels. I picked up some ideas that we may try here in Albuquerque. I also found out that approximately 60% of state Leagues have part-time paid staff and a number of large cities have paid staff as well.

My disappointments? I continue to feel that LWVUS does not provide enough in the way of support for operating a local League. A local League president must be concerned largely with the details of running an organization, which is basically a small business. Assistance with such things as working with volunteers, running an office, putting together a plan, working with a nominating committee, etc., are not easily obtainable from LWVUS. I had an opportunity to sit down and share this with the national staff person who handles field support, and she was receptive, but I did not feel that others in our discussion groups understood this concept. Because the local League is the foundation upon which the entire organization is built, I feel it is imperative that we be strong and function well at the local level. Maybe someday I will have some success at getting my point across to others, and LWVUS can be of more assistance.

In the meantime, folks, LWV/ABC looks good and does not have many of the problems other Leagues are facing. We can thank a strong and supportive membership for that. Enjoy the rest of your summer.

## MY FIRST LWVUS COUNCIL

This June I attended my first LWVUS Council as a voting member of the New Mexico delegation. The program ran from 9 a.m. to 9 p.m., with relatively short breaks, which we used mainly to meet one another. I took 16 pages of notes, two pages of "to-dos," and three folders of supplementary information which I am still reading.

I attended the workshop "Safeguarding US Democracy: Promoting an Independent Judiciary by Defending the US Constitution," which included a 12-minute video on DVD. (If you'd like to borrow this DVD, it will be available in the LWV/ABC office.) This, and the other supplementary materials, were part of the US bar association's "Least Understood Branch" project. We were urged to work with our local bar associations to inform the public of its rights and the importance of the judiciary.

Another workshop, "Next Steps in Election Reform," discussed problems in election administration and some possible solutions. Attendees offered the experiences that had worked for them. We look forward to the results of LWVUS's ongoing study of why people don't vote, an update of the 1990's study. There were also excellent presentations, including a panel discussion on immigration, an issue on which the League plans to reach consensus this year. 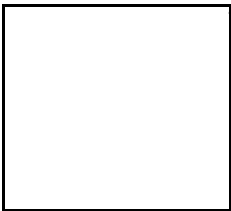
