Presidents' Corner

Our legislative reception Sunday, Dec. 5 went very well. We had about 50 people, including seven state representatives and senators, each of whom spoke a few minutes. They all agreed that budget issues will be the big focus during this session. Some anticipated that the problems would not all be solved during the session. One legislator made the point that we are really facing a major, short-term crisis because of the economic downturn. He believes we should not try to solve this short-term problem with drastic long-term restructuring and changes but with more appropriate short-term adjustments. Thanks for an outstanding meeting to Jo Porter, Andrea Targhetta and everyone who helped set it up, and especially to Carol Tucker Trelease for hosting the meeting at her house.

Our fundraiser at the Adobe Theater is scheduled for Sunday, March 6. So mark it on your calendar. The play is a mystery, *Wait Until Dark*. More details will follow in next month's *Voter*.

Jan and Olin represented the League Monday, Dec. 6, at a meeting of the local Society of Professional Journalists on ethics. Their code of ethics has a number of points in four areas -- seek truth and report it, minimize harm, act independently and be accountable. Some of the points the panelists made were: always check out multiple sources but consider their motivation for what they are telling you; during campaigns, when you get anonymous information about candidates, not only check it out, but also decide if it is really relevant; many media organizations try to maintain a brick wall between their reporting and marketing staff to keep advertisers from affecting stories; be aware that reporting is time- consuming and expensive. That is one of the reasons many organizations -- especially cable networks -- are moving more towards opinion pieces as opposed to reporting. Also, the dividing line between news and opinion is becoming fuzzier.

Somebody asked if Wikileaks was any different from the release of the Pentagon Papers during the Vietnam War. The panelists said that only a small part of the Pentagon Papers was printed by the press and only after a lot of fact checking and analysis. The panelists asserted that Wikileaks was dumping massive amounts of unchecked raw data with essentially no analysis and/or checking. If we are interested, the state president of the society is willing to set up a program for us. It is something to consider for one of

The Mid-Region Council of Governments conducts transportation planning for the Albuquerque Metropolitan Area. Packing Partisans. In 1991, Texas Democrats crammed loyal Texan Republican voters into a district that spanned hundreds of miles, taking small slivers of land from five counties. **By packing pockets of Republican voters** into districts like the one on the right, Democrats could give themselves a better chance in the districts next door. In 1992, Republicans and Democrats each won about 49

percent of Texas' statewide vote . . . but under the Democratic redistricting plan, Democrats won 70 percent of the state's Congressional races.

Note: The district shown in this picture is the one featured on the cover of the ACLU's "Everything You Always Wanted to Know About Redistricting But Were Afraid to Ask" report. Yes, that's one (1) congressional district. It kind of puts Tom Delay's 2003 re-redistricting into perspective. . .



What did visitors look at on the website?

Further analysis of the web statistics for October and November 2010 shows conclusively that the *Voters' Guide* Online was what nearly everyone wanted to see and little else.

The *Voters' Guide* PDF was downloaded about 5,500 times! Somewhat surprisingly, the elections page (gateway to the online *Voters' Guide*) was visited more times than the home page in October (5,000 vs. 4,400), suggesting that many visitors came in directly from the State's LWV election page at lwvnm.org, the only known direct link.

Throughout October and most of November, the pages of the Online *Voters' Guide* website (as opposed to the PDF file of the *Voters' Guide*) were accessed much more frequently than the rest of the

LWVCNM website. In particular, and in this order, visitors looked at the general information web page (corresponding to "Page 1" of the hard copy *Voters' Guide*), the Candidates (index) page, ballot issues (index) page, the details of the state amendments, statewide candidate responses to questions, U.S. Congressional candidate responses and details of State Bond issues.

It is hard to escape the conclusion that visitors will check out lwvnm.org if -- and only if -- they feel there is valuable information there. -- Cheryl Haaker
