## New Mexico Economy Topic of Annual Meeting Brunch

Lee Reynis, director of the Bureau of Business and Economic Research at the University of New Mexico, will be the guest speaker at the May 3 Annual Meeting of the League of Women Voters of Central New Mexico.

Reynis will discuss New Mexico's economic status, taking a look at the state's recovery rate and comparing it to other states. Also, she will talk about

the types of people, skills and jobs the state needs.

Reynis became director of the BBER in 1999. Prior to that, she was the City of Albuquerque's economist and chief economist for the New Mexico Department of Finance and Administration. She is involved in producing the quarterly economic forecast for New Mexico and for Albuquerque, Santa Fe and Las Cruces. Some of her research has included studies of the Santa Fe living wage, the management and future of federal investment in New Mexico and several studies of New Mexico health care. She has a Ph.D. in economics from the University of Michigan.

## Book Report: What Went Wrong?

*Editor's Note: Book Review -- This review of an important public policy book is a regular feature in the Voter.* by Olin Bray, author of ebook, *Political Incompetence: What's Wrong With Our System and How To Fix It*

*What Went Wrong: How the 1 % Hijacked the American Middle Class and What Other Countries Got Right*, George R. Tyler, 2013, Benbella Books, hardcover, 563 pages.

This book explains the causes of U.S. economic stagnation since the 1980s. Consider the growth in total employee compensation since 1985 – 220 percent in Denmark, 194 percent in Germany, 192 percent in the Netherlands, 154 percent in France, 64 percent in Australia and 0.47 percent in the US. Obviously, something is seriously wrong. I say "explains" because he focuses on data and analysis rather than ideology and myths.

The critical measure of economic performance is growth in productivity because without that real wages and standards of living cannot increase. During our "golden age," from 1946 to 1972 our average annual productiv-

ity grew at 2.8 percent, but since the 1980s and Reaganomics it dropped by a third to only 1.9 percent. Meanwhile in Western Europe, with what he calls family capitalism, productivity has been growing about 30 percent faster than in the U.S., which explains why their wages are now higher than ours. We have become the low wage competitor, with all of the problems that entails. Furthermore, he contends that simple GDP/capita is not a good economic measure if economic growth is not equitably distributed.

He makes a strong distinction between Reaganomics and what he calls "family capitalism," which is what is seen in most other developed democracies. The characteristics of Reaganomics are shareholder capitalism, a culture of selfishness, regulatory capture, weak corporate governance, and illusory prosperity. On the other hand, family capitalism is characterized by stakeholder capitalism, a culture of responsibility, wariness of corporate influence, codetermination, and genuine wealth creation. All of these characteristics are related. With shareholder capitalism the only

concern is to maximize shareholder value, which makes the economy a zero sum game and generates a short term, selfish approach to corporate decision making. This has led to under investing for the future, lack of innovation, and not training the workforce. On the other hand, stakeholder capitalism explicitly recognizes that there are many players in the economy and that gains need to be balanced among them. The economic and political system explicitly punishes excessive greed and punishes attempts to circumvent reasonable regulation. For example, in the U.S. corporate misbehavior gets token punishment, low fines compared to revenues and profits, and little CEO and board accountability. However, in Australia a shopping center owner who falsified his books got a verdict that wiped out 18 months of earnings. Another Australian company that played games to avoid asbestos liability was heavily fined and its CEO and board members were banned from other boards for up to 15 years.

The two main sections of the book describe in detail the shift that has occurred in the U.S. economy and the results of these changes in many areas. The final section focuses on rebuilding the American dream and American family capitalism.

I strongly recommend this book, even if you only read the first and last sections and skip most of the detailed analysis. However, it is frustrating because a number of other well respected authors, including a Nobel prize winning economist, have made similar cases using

much of the same data, but very little is changing. Many of the things we need to do are obvious, not unknown. Unfortunately, a lot of myths need to be destroyed and the culture needs to be changed. If people don't realize there is a problem or recognize its seriousness and don't accept that many other countries are doing significantly better than the US economically, then little will change. than she seems to realize.

In summary, this book points out some serious problems that must be addressed, but it is less helpful in proposing solutions. However, in identifying these problems and their seriousness the book provides an incentive to try to find viable, i.e. real and politically acceptable
