Timothy Beck, a Social Studies teacher at Sandia High School, will be our featured speaker at the LWVCNM July 13th<sup>th</sup> luncheon meeting. His courses include Advance Placement U.S. Government and Politics, AP Economics with an emphasis on Macro Economics, and the International Baccalaureate History of the Americas, which covers U.S., Latin American, and Canadian history from 1492 to present. Mr. Beck has previously taught regular Government and Economics, AP World History, and regular World History. He earned his bachelor's degree in Economics as well as a Master's in Business Administration and Econometrics from Miami University in Oxford, Ohio.

#### **News From LWVUS National Office**

The League continues our commitment to redistricting reform with lawsuits in North Carolina and Pennsylvania. Meanwhile, Ohioans are collecting signatures to get a gerrymandering elimination item on the November 2018 ballot

The League of Missouri has also joined in <u>a suit</u> <u>against the state's photo ID law</u>. And in Florida, the League is <u>asking state justices to determine</u> <u>who appoints successors to justices</u> whose terms end the day Governor Rick Scott leaves office

From New York, <u>The Union Edge</u>, Dare Thompson and Laura Bierman of LWV New York State chatted on the history of the suffrage movement and how laws in NY make it difficult for people to vote how they want.

#### Website Reviews

### **Budget Model**

The League of Women Voters and other groups interested in public policy have always tried to analyze issues, but unfortunately were often limited to high level qualitative results such as taxes should be progressive, fair, efficient, and a collect the money needed to fund the government. The two websites reviewed this month can dramatically change that. The Wharton School at the University of Pennsylvania has democratized the policy analysis process by providing easy access to the types of data and models rarely available except to government agencies such as the Congressional Budget Office (CBO) and well funded think tanks and universities.

The first site (http://

www.budgetmodel.wharton.upenn.edu) uses detailed census, demographic, economic, and tax data to calculate the effects various policy options. The models address (or soon will include) tax policy, social security, immigration, health care, housing finance, education, retirement, criminal justice, and regulatory issues. For example, for social security, what would be the effects of raising the cap on the tax to \$200K or \$400K or raising the full retirement age by one year. Their model calculates the effects of these proposed changes. How much would SSA take in and payout and how would it affect the SS Trust Fund? By varying the model parameters you can explore the effects of over 4096 different policy alternatives just for social security, with additional alternatives for the other policy areas.

In addition to allowing anyone to work with their model, the Penn Wharton Budget Model (PWBM) project also does their own analysis of \_-4 various policy proposals, including new ones as they come up in Congress or other governmental or non-governmental sources. Their reports explain the results of their analysis and where they disagree with other models such as the CBO's they explain what the differences are and why they occurred. The PWBM is non-partisan and non-normative. They only analyze and explain alternatives. They do not propose or recommend any policy alternatives, which makes them even more non-partisan than the League. The project director is Kent Smitters, who was an economist for the CBO, Deputy Assistant Secretary for Economic Policy at Treasury, and a consultant for the World Bank and the Urban Institute. He has a staff of 12 to support these sites and their analyses.

Regardless of how good the model is, without good data the results are worthless. Therefore, the project also has a comparable website for the

data (http://USAFacts.org). The models use data from this website, which is also accessible independently. It includes data from government and other sources for data on population, demographics, economic, income, taxes, education, crime rates, etc. It is similar to an online version of the Statistical Abstracts of the US. Even if you don't use the analysis models, this site is a good source for a lot of critical data to determine what policies are or are not working.

Take a look at both of these sites and have fun. Later we may want to have a meeting exploring these sites in more detail. Olin Bray

NM State law decrees that city elections are Non Partisan but our County and State Elections are Partisan. Why? Because the State can make such decisions!!


