#### "JUDICIAL SELECTION IN NEW MEXICO"

LWVCNM invites you to attend our November 14, 2019 luncheon meeting to hear a very esteemed panel. The Chair of New Mexico's Judicial Nominating Commissions and the Dean of the University of New Mexico School of Law, Sergio Pareja, will provide an overview of the judicial selection process in New Mexico. He also will review the three bills related to judicial selection that were introduced in the last legislative session, SJR 12, SJR 15, and SJR 19. This will be followed by a panel discussion on issues with the current judicial selection system, ideas for reforming the system, and possible insight into what we might expect to see in the next legislative session. The panel will consist of Dean Pareja, New Mexico Court of Appeals Chief Judge Monica Zamora, and New Mexico State Bar President Jerry Dixon.



M. Monica Zamora joined the New Mexico Court of Appeals in December 2012. She was elected to



Judge Zamora graduated from the University Of New Mexico School Of Law in 1987. She was admitted to practice in the State of New Mexico in 1987; the U.S. Federal District Court for the District of New Mexico in 1988; in the U.S. Court of Appeals for the Tenth Circuit in 1988; and in the United States Supreme Court in 2000. Judge Zamora

is a member of the New Mexico Hispanic Bar Association and the New Mexico Women's Bar Association. She has received the Governor's Award for Outstanding New Mexico Women (2008), the CLE Summit Award for Ethics & Professionalism Credit awarded by the State Bar of New Mexico and The Center for Legal Education (2012), and the Henrietta Pettijohn Award from the New Mexico Women's Bar Association (2013).

Sergio Pareja is the Dean of UNM School of Law. Prior to joining the UNM law faculty, he practiced tax and estate planning in Colorado and Indiana. Dean Pareja commonly teaches courses in the areas of tax and estate planning. In 2011, he was identified by as one of the top law teachers in the country: The Bucket List: 23 Law Profs to Take Before You Die. In 2013, Pareja was honored by the University of New Mexico with a university-wide Outstanding Teacher of the Year award. Dean Pareja also is New Mexico's first ever Academic Fellow to the American College of Trust and Estate Counsel (ACTEC). Dean Pareja is the founding director of UNM's Madrid Summer Law Institute. In his role as Dean of the law school, Dean Pareja serves as Chair of all Judicial Nominating Commissions in New Mexi-



co. Outside of his interests in the law, Dean Pareja is a dedicated guitarist. He got his J.D. from Georgetown and his B.A. from UC Berkeley.



Jerry Dixon is a shareholder at Dixon•Scholl•Carrillo•P.A. and has practiced law for 38 years in the areas of professional malpractice defense, licensing, commercial and construction litigation and real estate. He is currently the President of the State Bar of New Mexico. He is a frequent speaker to professionals on ethics, professional liability and risk management issues. Jerry was President of the Albuquerque Bar Association in 1994. He has participated in the New Mexico high school mock trial program since 1988. Jerry was named Outstanding Attorney of the Year by the Albuquerque Bar Association in 2014 and received the 2014 Distinguished Service Award from Texas Tech University

School of Law. Jerry served as a visiting Professor of Law in 2012 at the University of National and World Economy in Sofia, Bulgaria and in 2015 at South-West University in Blagoevgrad, Bulgaria.

The League of Women Voters of New Mexico has long supported merit selection for appellate and district court

judges and Supreme Court justices in New Mexico. Since the time that merit selection was enacted in the State, many new members have joined the League and, as always, we desire to refresh our members' understanding of this important process for a key branch of our Government. In addition, the League's renewed interest in the selection of judges has resulted from a State study adopted at LWVNM Convention in May 2019. The two-year study is on the "Qualifications and Selection of Judges of the Lower Courts." Suzanne Ronneau (LWVSFC, State Board Treasurer) proposed the study and will serve as study chair. Committee members are Mary Wilson, Mary Smith, Janet Adelaide Jacobson. Committee welcomes additional members. #### Study Plan for the Qualification and selection of Lower Court Judge....

• Determine the current legal requirements for qualification of judges of the "lower courts" or "Limited Jurisdiction Courts," -- magistrate courts, municipal courts, and probate courts.

- Review the positions of other State Leagues regarding legal requirements.
- Determine the adequacy of the current legal requirements to assure optimal justice for New Mexicans by interviewing judges of the lower courts, interviewing citizens having cases in these courts to the extent practicable to determine whether the current judges are doing an acceptable job. In addition, consider what other minimum requirements should be instituted (i.e. requirement for certain level of educational achievement, status as a New Mexico attorney.)
- Study whether the selection process, i.e., partisan elections, is optimal, by comparing current selection processes in other States.

The first year will be aimed at educating the committee and League members as to the current status and the positions of other state Leagues. The second year will be aimed at developing questions for consensus for an amended state position, if deemed warranted after study.

The Study committee will hold its first meeting in the Embassy Suites lobby at 11 am immediately prior to the Nov. 14 luncheon. The committee will caucus again after the luncheon to refine their work based on what they have heard from the panel discussion.

The Voters' Guide always provides insight to voters when there are many decisions and when LWVCNM can offer the public each candidates' perspective on the issues in a fair presentation easily understood.

This year was a learning experience as the Voters' Guide covered city council, Albuquerque Public School Board, Central New Mexico Community College Governing Board, Albuquerque Metropolitan Arroyo Flood Control and Ciudad Soil and Water Conservation District races. This year we also included local races in the Villages of Tijeras and Los Ranchos de Albuquerque. Special thanks are due to Mary Wilson for organizing the guide, to Janet Blair for searching out the candidates, to Jeanne Logsdon for organizing proofreaders, and to Andrea Targhetta for organizing the distribution of the Voter Guide and to Mary Smith for handling all the requests for candidate forum moderators. LWVCNM would also like to thank the Bernalillo County Clerk Linda Stover for allowing us to place the guides in the early voting centers. This year voters are going to need the guide more than ever as they face down the 14 bond questions and try to translate the ballot questions into practical terms.

Our nation is going through difficult political times, and the work we do to educate voters on local political candidates and concerns is more valuable than ever. Thank you to all the leaguers who work to keep our democracy on track every day. It might not seem like much day to day, but the grass roots of democracy keep the political landscape strong.

ETHICS IN ALBUQUERQUE GOVERNMENT....Co-Presidents Karen Douglas and Karen Wentworth joined other dignitaries at the ceremony of Mayor Tim Keller signing the City's Ethics Reform Ordinance that added important provision to the city Ethics Code.

Among many other important provisions, it added additional qualifications for members of the Board of Ethics including that members shall not:

—Have held public office as a City official or have been a candidate for public office as a City official for a two-year period prior to appointment;



- —Participate in any political campaign for a ballot initiative, City official or a candidate for elective office as a City official while serving on the Board;
- —Be a Lobbyist, or be employed by or have an equity interest or ownership interest in a Lobbying Organization, as defined in ROA § 2-3-3, while serving on the Board;
- —Be a paid political campaign employee, or be employed by, or have an equity interest or ownership interest in, a business entity that derives any of its revenue or income from political campaign work, while serving on the Board;
- —Have a Contract with the City as defined in Article XII, Section 2 while serving on the Board;
- Publicly endorse or publicly oppose a candidate who is a City official or a candidate for elective office as a City official while serving on the Board.

## WHY I HAVE MADE A BEQUEST TO LWV CNM IN MY LAST WILL AND TESTAMENT.

I have made a practice of attending most Luncheon meetings of LWVCNM and the Monday morning meetings at La Vida Llena to learn how the various parts of Governments in New Mexico work and how they could be improved. Yes, meaningful changes take time and my patience level on a scale of 1-10 is very close to 12,469, but I can wait it out.

LWV members like Andrea Targhetta, Dick Mason and Diane Goldfarb have been very helpful in showing me the League processes and so I have learned from them and also by working with Common Cause NM, ACLU New Mexico and other organizations.

The Independent Ethics Commission will begin this January...after about 20 years of procrastination by the State Legislature and Governors. When I moved here about 21 years ago, voting in person was held at each voter's specific polling place and in a few years, with the help of computers, voting in person could be at any of more than a dozen centers. So, the LWV CNM monthly meetings, and many of its members, have given me the knowledge of our many governments and how changes might be made. This education will be rewarded by a generous contribution through my estate.

To aid this process, I worked to create the JoAnne Ramponi Society\* which recognizes those people who will help LWV CNM financially. And so I ask that you do the same.

What does LWV CNM need money for?

LWV CNM is chartered to provide voter educational services in four counties: Bernalillo, Sandoval, Torrance and Valencia. Most members live in Bernalillo County with about a dozen in Sandoval, four in Torrance and NONE in Valencia. Recently some people in Socorro County asked about forming a league down there. Expanding LWV efforts to more people is, I deem, vital to having active voters informing themselves on issues and candidates and then working to improve our governments.

Further, as more people adopt various social media for their information, and drop newspapers/TV/ radio, getting "The Voter Guide" to people or driving them to read it on line is vital. As of August 29, the NM Secretary of State reported just over 416 thousand registered voters in Bernalillo County, yet LWV CNM prints many fewer copies of The Voter Guide to inform voters. Either LWV CNM finds a way to get more print copies in peoples' hand and then their minds, or LWV CNM needs programs to be more effective with social media to get into voters' smart phones/tablets/computers.

Sandoval County has about 97,000 registered voters and is growing rapidly, so I deem that this county should be an important goal for LWV CNM. But having lunches/coffees to get more members there will take some money and planning/time for current members to make it happen. Valencia County has over 42 thousand registered voters and is a good target, but only with planning and meeting leaders down there.

So, if you are leaving money in your estate plans to a not-for-profit organization, please consider naming LWCNM in your plans.



But why am I leaving money in my Will to LWV CNM and not now? My wife and I do not want to be a burden on our children or grand children so we wish to be financially self sufficient now but we feel comfortable leaving money for the League at our deaths. Attendees at the October LWVCNM luncheon enjoyed learning about plans for



At the October luncheon we heard that some members have been getting phishing emails claiming to be from the U.S. Census Bureau. Our speaker explained that the U.S. Census Bureau will never contact you by email unless you specifically go to the Census website and subscribe to its newsletters. So, we thought Members would like to have some information about defending themselves against spam email:

Your first line of defense is asking questions about whether the Census (or any other organization) would reach out to the public this way.

But what can you do in the moment as you sit at your computer to check if an email is legitimate? Errors in the sender name or the subject line are one indicator. Another simple step is to see if the name listed as the sender matches the email source. How do you do that? Take your cursor and let it "hover" over the text for the sender name. Don't click on the name; just align your cursor over the name. When you hit the right spot, you'll get a box showing where the email is coming from. For example, I buy things online from Land's End, so they have my email. If I see Sender: Land's End Subject line: Got a few seconds? Create your shopping account today!, I am not going to waste my time opening it because I don't want to create a shopping account, but I can guess it is probably really from Land's End. I can confirm this by hovering over the sender to see that the email this came from is land-send@email.landsend.com. The sender name and the source email line up: this is a legitimate email.

I also subscribe to Rep. Deb Haaland's email newsletters. For her the sender is Representative Debra Haaland, and by hovering, I see the source email is NM01DH.Outreach@mail.house.gov. The email wording is a little more convoluted, but all the elements of it still relate to Deb Haaland and show a legitimate connection. But here's one that isn't so clear: Sender: 3 Bureau Credit Scores Subject line: Don't let Labor Day Overwork Your Credit It's possible this is from a legitimate source wanting to help me check my credit score . . . By hovering my cursor over the sender, I see the actual source is contact84Jou14TA@crawlinginside.com. The sender name and source email do not align, which is enough to know this isn't legitimate, but the source email also looks pretty sketchy. This is not even worth opening, so into the trash it goes. It is also possible for the sender to look a little more legitimate than this example does, but still be spam, like these U.S. Census Bureau emails. The bottom line is don't open an email if you are not expecting it, but when in doubt, use the above tool to check out an email.

#### MAGDALENA, NM.....

On September 28, Karen Wentworth, Mary Wilson and Hannah Burling traveled to Magdalena to meet with a group of local residents who are interested in doing League work in their community. We told them about the league, what we do, our history and current work in New Mexico. They told us about their concerns about voter registration and voting in their community and about the issues they would like to focus on. One particular issue caught all of our attention because it concerns a group of citizens who need to be better integrated into the voting population, i.e. individuals with disabilities. The group told us about work being done in Colorado under the REV UP! Program created by the American Association of People with Disabilities. REV UP stands for register, educate, vote, use your power.

We welcome members from Magdalena and the surrounding community to join LWVCNM so that they can start working on this important voting rights issue under the League umbrella!

Here are some interesting nationwide statistics about Disability and Voter Turnout in the 2016 Elections compiled by Professors Lisa Schur and Douglas Krusel of Rutgers University:



Magdalena area residents.

- 16.0 million people with disabilities reported voting in the November 2016 elections. The voter turnout rate of people with disabilities was 6 percentage points lower than that of people without disabilities.
- Employed people with disabilities, however, were just as likely as employed people without disabilities to vote, suggesting that employment helps bring people with disabilities into mainstream political life..
- The voter registration rate of people with disabilities was 2 percentage points lower than that of people without disabilities. The lower voter turnout was due both to a lower registration rate among people with disabilities, and to lower turnout among those who are registered.
- If people with disabilities voted at the same rate as people Pictured above are Mary Wilson and three without disabilities who have the same demographic characteristics, there would be about 2.2 million more voters.


