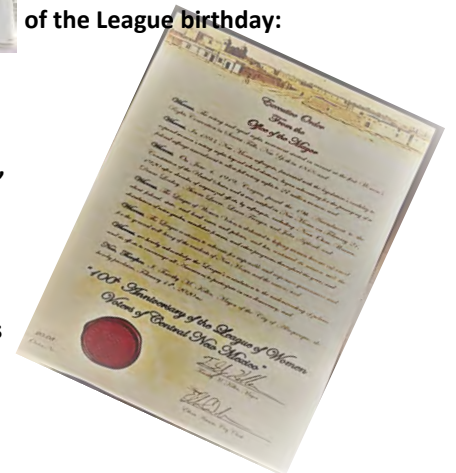

Although there were no bills aimed at decriminalizing abortion introduced during the recent short legislative session, lawmakers did take up other bills concerning women's reproductive rights. Our March speaker, **ELLIE RUSHFORTH**, will talk about what happened in the area of reproductive rights during the legislative session, and she will bring us up to date on what is happening in New Mexico and in the nation relating to abortion and reproductive rights in general.



Ellie is the reproductive rights attorney for the ACLU of New Mexico. Previously she was a senior staff attorney at the Southwest Women's Law Center where she worked on economic and reproductive justice. A native New Mexican, she has a B.A. from UNM and a law degree from the University of Arizona. Her work at the ACLU is centered on protecting and expanding access to reproductive rights. Her work is grounded in the belief that reproductive justice is the cornerstone of self-determination and bodily autonomy and that everyone deserves equal and meaningful access to the care they

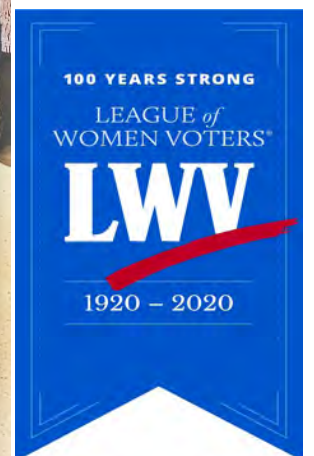

The LWVCNM February 2020 activities focused on Suffrage Celebrations and observance of the February 14, 1920 founding of the League of Women Voters of the United States. LWVCNM participated with the three other NM local leagues; women's organizations representing select professions, minority institutions, and political causes; and elected officials in the February 6, 2020 Suffrage Centennial observations held in the NM Roundhouse during the 2020 Legislative Session.

The February 15, 2020 LWVCNM 100<sup>th</sup> Birthday Party recognized the varied and outstanding achievements of 10 LWVCNM Lifetime members, each with more than 50 years membership. Multiple members of the LWVCNM Suffrage Committee, chaired by Dr. Jeanne Logsdon, dedicated long hours to prepare a suitable ceremony and collaborated to assemble 99 LWVCNM members and

friends to celebrate the accomplishments of these lifetime contributors. ### Making Change:

#### They Won the Vote - Suffrage and Suffragists in New Mexico

Saturday, March 14, 2020

The campaign for woman's suffrage in New Mexico is rich and deep. But, as with other aspects of women's lives, most of their stories—political, economic, social—are not found in history books. This talk By Dr. Sylvia Ramos Cruz travels from suffrage nationally to suffrage and suffragists in New Mexico. Some of the protagonists in this story, such as Adelina Otero Warren and Octaviano A. Larrazolo, are well known historical figures. Others, including Ada McPherson Morley, Isabella Selmes Ferguson, Cora Armstrong Kellam, and Evelyn Fisher Frisbie are less so. We'll look at some of the women and men whose contributions to that 72-year-long struggle are still being unearthed in family lore, memoirs, songs, newspapers, and a few precious, oft-quoted scholarly works.



The speaker, Sylvia Ramos Cruz, is a retired general surgeon, poet, writer and women's rights activist. Her ongoing creative work focuses on women's history in New Mexico. The centennial of the 19th amendment to the US Constitution, Woman's Suffrage, inspired her to research and write about the suffrage movement here and the people who took part in it.

### LWVUS Board Sets Legislative Priorities

The LWVUS Board set the following as legislative priorities for the 2020 session of Congress.

1. Campaign for Making Democracy Work® (MDW), with special emphasis on redistricting campaign, voting rights protection, and promoting public financing under money in politics;
2. The Equal Rights Amendment and removal of the ratification deadline; and
3. Watchdog: Respond strategically on issues with LWV positions when needed related to climate change, gun safety, and immigration.

## SPOTLIGHT ON JAN STRAND.....

This is the second in a series articles called "Spotlight" which will feature interviews of current Board Members by Trish Lopez. The first article features Treasurer Jan Strand. Just for fun, Trish has included some pictures here of Jan in earlier years.

**Name:** Janice (Jan) Strand

**Where are you from?** Plainview, Minnesota (near Rochester)

**Did you go to college? If so, major: -**

University of Minnesota – B.S. Home Economics Education

Texas Tech University - M.S. Family Studies/Human Development

**How long have you lived in ABQ?** 6 ½ years (in NM 47 years- first in Roswell and rural Santa Fe)

**What inspired you to get involved in politics and voter rights?**

I grew up with parents who were involved in community/farm/church organizations. My father served on the school board and township board., etc. A nephew served three terms in the Minnesota House of Representatives, being elected at age 24. My husband served on the city council in Roswell.

My last year of teaching in Roswell (1979-80), I served on Mrs. King's Committee on the Family and connected with the Human Services Dept, etc. After I finished my M.S. Degree, I decided not to go back to teaching school. Because there had been a horrible molestation case in a family day care home, I set to establishing and directing a non-profit child care resource and referral agency. I organized a task force that conducted a community-wide survey. With data and testimonials, I, along with the Albuquerque Carino Program at the YWCA, testified before the Legislative Finance Committee and other House and Senate Committees during the session and were able to get funding.

I also worked with a similar task force to establish another non-profit board that funded a nursery for the children of high school students and chaired the board for 4 years. Later I served on the board of NMOAPP, begun by Mrs. King and served on Governor Caruthers' Task Force on the Adolescent Pregnancy and Parenting.

In early 1990 (after my husband died), living in rural Santa Fe, I established and directed a non-profit child care resource and referral agency in Albuquerque to serve corporate parents. Both CCR&R programs continue to sponsor the child care food program, a government program, so this has involved working with the Children, Youth, and Family Department.



**Why are you a member of LWV?** After I moved to Albuquerque in 2013, I decided I wanted to be part of an organization with committed and active membership with a citizen-oriented purpose.

**What led you to where you are today?** Being guided and encouraged by great mentors!

**What is the most rewarding part of serving on the LWVCNM Board?** Working with and getting to know a group of dedicated women.

**What is your favorite law that has been passed in NM?** Establishing the Children, Youth, and Family Department

**Please share one quote or life lesson that you try to live by:**

Never to tire, never to grow cold,

## LWVCNM PLANS FOR BANQUET FOR 19TH AMENDMENT CENTENNIAL.....

The 2020 Centennial Celebrations Committee is now focusing on the banquet, to be held on August 29 at the Sheraton Albuquerque Uptown from 5:30 to 9. The keynote speaker is Roberta Cooper Ramo, a prominent local attorney and past president of the American Bar Association. She is also a strong supporter of the League of Women Voters.

We envision the banquet as an opportunity to celebrate our two Centennials and also as a major fundraising event. Here is how we are reaching out to banquet sponsors:

LWVCNM is entering a new phase of study and action to strengthen American democratic institutions. The Voter Guide is being expanded to include the primary election and offices in all four counties in our region (Bernalillo, Sandoval, Torrance, and Valencia). We are designing a stronger online Voter Guide through LWVUS's Vote 411 initiative. The Voter Guide is prepared annually and has been expanded because county, municipal, and school board election, and special district such as the Ciudad Soil and Water Conservation District schedules have been consolidated. We have also embarked on a new project to publish a booklet, "Know Your Government," to explain how the City of Albuquerque and Bernalillo County work.



In order for this new phase of study and action to be successful, we need more resources. Increasing the frequency, number of elected positions, and areas covered by the Voter Guides requires higher printing costs. We need to upgrade office electronics and equipment. And we need more space for volunteers to meet and work on projects.

So you can see that we are setting ambitious targets for banquet attendance and fundraising. The timetables, we expect that the sponsorship visits to major donors will take place in late March. In April the silent auction effort will begin and continue through June. The invitation subcommittee will get to work in May so that invitations can be mailed in late May and June. Five subcommittees are already at work on the banquet: Fundraising, Silent Auction, Budget, Publicity/Graphics, and Invitations. Several other subcommittees will be formed over the next few months, including Program and Decorations. Volunteers are needed for the many tasks to make this a successful event. ## APD Efforts to resolve Court Approved Settlement Agreement Measures – 2020 Transition

LWVCNM Has been a Coalition Partner in the Albuquerque Police Department Forward activity since 2014 to ensure transformation of APD police practices and institute Constitutional Policing. The Instances of Excessive Use of Force (UOF, including deadly force) by the Albuquerque Police Department (APD) 2010 – 2014 prompted citizens' groups to request intervention by the US Department of Justice (DOJ). The subsequent investigation by Paul Killebrew, JD and DOJ Special Council for the Civil Rights Division in Washington, DC, resulted in findings released April 2014. The November 2014 Court Approved Settlement Agreement (CASA) between the US Department of Justice (DOJ) and the City of Albuquerque was negotiated and identified eight areas requiring APD corrective measures. The CASA has included quarterly evaluations with reports released by the Independent Monitor (IM), Dr. James Ginger, who previously served in this capacity for other metropolitan police force proceedings. The Federal Judge overseeing the IM (previously Judge Brack, now Judge Browning) convenes Hearings with arguments from the Independent Monitor, US DOJ (US Attorney's Office) and the City of Albuquerque/APD with opportunities for concerned citizens' groups to weigh in.

Dr. Ginger's staff prepares quarterly reports detailing APD Progress in accordance with three levels: Primary (Approved Policies), Secondary (APD Officers effectively trained to revised Policies) and Operational (APD Officers effectively applying the new practices in the field). The most recent July 2019 CASA Amendment included nine broad categories with 276 measurable compliance paragraphs – 66 Paragraphs that APD has achieved Operational level compliance for more than two years were proposed for transition during February 2019 to APD Self-Assessment Monitoring by the APD Accountability and Oversight Division, with agreement from both the US DOJ and Independent Monitor Dr. Ginger. The CASA Sections including these 66 operationally compliant paragraphs were: Multi-Agency Task Force; Behavioral Health Training; Field Training Evaluation Program; Recruitment, Selection, and Promotions; Staffing; Promotions (will be formalized as a Municipal Ordinance); Specialized Units; Specialized Tactical Units; Specialized Investigative Units; Public Information on Civilian Complaints; and Officer Assistance & Support.

The February 11, 2020 Hearing to evaluate the 10<sup>th</sup> IM quarterly Report covering the period ending in August 2019 also included mention of this Self-Assessment proposal. During the subsequent February 12<sup>th</sup> meeting with Assistant US Attorney Elizabeth Martinez, Independent Monitor Dr. Ginger, Managing Albuquerque Assistant Attorney Lindsay Van Meter, and APD Deputy Chief Garcia, representatives of the APD Forward Coalition; the Community Coalition represented by Alfred Matthewson, Dean Emeritus, UNM Law School; Civilian Police Oversight Agency represented by Ed Harness; Community Policing Council representatives; and the Albuquerque Mental Health Response Advisory Committee requested a continuance of the February 26<sup>th</sup> Hearing scheduled until a thorough evaluation of the City's Self-Assessment plan could be completed. Following the February 26<sup>th</sup> meeting with the Assistant US Attorney, City of Albuquerque Attorney, APD Chief, and APD Accountability and Oversight Division, this request by citizens' groups was granted and a Hearing to transition compliance evaluation to the City of Albuquerque will be scheduled in early April 2020.

Notable discussions during the February 11<sup>th</sup> Hearing before Judge James Browning to evaluate the IM's 10<sup>th</sup> Quarterly Report included "improved APD Culture of respecting compliance and transition" from prior "Lawyer-Culture" to current "Guardian Culture with fair discipline" as Mr. Killebrew, US DOJ Special Counsel of the Civil Rights Division, noted that prior APD discipline was without a formal process, and therefore, was non-uniformly applied. Since release of the 10<sup>th</sup> Quarterly Report covering the period prior to August 2019, more of the CASA paragraphs have transitioned to Operational Compliance. The Hearing scheduled in early April to consider the Albuquerque Police Department's Self-Assessment Plan will be open to the public and interested LWV members are encouraged to attend.

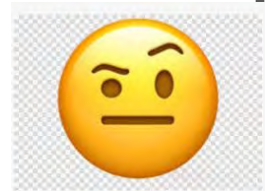
