

IN MEMORIAM....JUSTICE RUTH BADER GINSBURG

When United States Supreme Court Justice Ruth Bader Ginsburg died September 17, 2020, we lost a key ally in preserving the rights of voters. In her remarkable dissent in the 2013 decision in Shelby County v. Holder, she sided with all of us who know that voting rights are still under attack.

In the Shelby case the majority of the Supreme Court struck down a huge section of the Voting Rights Act of 1965,

which was enacted to ensure no citizen would be denied the right to vote because of race or color. It created a rule that applied to states and political subdivisions with a history of significant discrimination against Black voters in the 1960s and 1970s. This discrimination included impossible literacy tests, administered only to Black people and poor white people and devices like Mississippi's notorious soap-bubble test, which required Black voters to correctly guess the number of bubbles in a bar of soap in order to vote. The act prohibited the old discriminatory tests and devices and required those jurisdictions to submit any new changes in their



voting procedures—closing or moving polling places, reduction in early voting days, purges to voter rolls—to either the Justice Department or the district court in the District of Columbia for approval before they enacted them, a process called "preclearance."

In finding the act unconstitutional and ending the preclearance requirement for the covered states and counties, Chief Justice Roberts held that the "blight of racial discrimination in voting" that had "infected the electoral process in parts of our country for nearly a century," and which the act was designed to address, had been ameliorated by 2013.

Justice Ginsburg knew this was not accurate. That is the dissent in which she uttered the now famous statement: "Throwing out preclearance when it has worked and is continuing to work to stop discriminatory changes is like throwing away your umbrella in a rainstorm because you are not getting wet." She summarized her dissent from the bench, an unusual move and a sign of deep disagreement, in which she said that the legacy of Rev. Dr. Martin Luther King Jr. and the nation's commitment to justice had been "disserved by today's decision."

Parliamentary Pointers...... Skillful Presiding....Carrying out the Agenda

The presiding officer, usually the president of the organization, can skillfully set the tone for any meeting. In presiding, this officer can lead the group through a productive session.

Call to order on time! State "The October meeting of the League will come to order."

Quorum – Determine if the quorum stated in the bylaws is present; presence of quorum does not have to be stated at the meeting.

Approval of Agenda – "Are there corrections to the agenda? (pause) If there are no further corrections, the agenda is adopted as printed/corrected."no motion is needed as this is an assumed motion.

Adoption of Standing Rules – "You have a copy of the standing rules recommended by the executive committee. If there is no objection, the rules will be adopted. There being no objection, the rules are adopted for this meeting." Reading/Approval of Minutes – "Are there corrections to the minutes?.... If there are no further corrections, the minutes are approved as printed/read." (an assumed motion).

Reports of Officers - Call upon officers who do have reports. Reports are not adopted.

The treasurer's report is filed.... an annual audit report is <u>adopted</u>. An officer report may recommend a motion; the motion is made by another person, not the officer.

Reports of Boards – The report is not adopted; a motion may be brought forth from a board or executive committee. Because the board/committee is proposing the motion, no second is needed.

Reports of Standing and Special Committees – Committee reports are not adopted; again, a motion may be brought forth and no second is needed if the committee consists of more than one person.

Unfinished Business and General Orders – Items on the agenda from the previous meeting but not completed at that meeting or items postponed from the previous meeting. The items are introduced using a motion. (Old Business is no longer used!!)

New Business – "The next business in order is New Business." The presider recognizes members who are entitled to the floor....after they stand/raise their hand. When motions are made, the presider states the motion and conducts discussion/debate (covered in a later column).

***The presider protects the group/assembly from obviously frivolous/dilatory motions and enforces the rules relating to debate....No Getting OFF the Subject!!

***The presider expedites business by asking for motions and assuming motions (covered in a later column).

Adjournment – Usually, no motion is needed. "If there is no further business, the meeting is adjourned." Presiding Tips

- 1. Knowledge is strength. A presider who is familiar with correct usage of parliamentary procedure can skillfully guide a group through many issues in a short time.
- 2. A skillful presider maintains control over the progress of the meeting...and expedites business by informing the membership of correct procedures....in a diplomatic way!
- 3. A skillful presider keeps the membership informed by stating the specific issue/motion being considered and the necessary steps to complete the business at hand.

FROM THE DESK OF THE CO-PRESIDENTS.....This has been one of the most difficult election cycles the League of Women Voters of Central New Mexico has faced in recent times. We haven't safely



been able to go out to register voters, and some of our normal voter education activities are competing with dozens of new groups also seeking to educate votes in this very controversial election.

We can't thank board members enough for their outstanding generative to the loggue. Every day you go so much above and beyond

erosity to the league. Every day you go so much above and beyond what is asked of you. We just wanted to take this change to say Thank You out loud.

Our fundraising messages to the membership raised about \$7,000.

That is less than the cost of the Voter Guide this year and we have asked Gege to put together a small committee to organize additional fundraising

after the general election. Anyone who is interested in serving on the committee should talk with Gege. The Voter Guide effort has been long and arduous. Our great appreciation to everyone who is involved in this effort. We have expanded the guide to include all four counties that we serve and that did increase the cost of the guide slightly. We are still working with Bernalillo and Sandoval Counties to determine whether the guides will be available at the voting convenience centers. Mary Wilson, Ashley Benning, Cheryl Haaker, and Mary Smith have done extraordinary work in putting the guide together, and Jeanne Logsdon and her proofreading committee are preparing to put the finishing touches on the Voter Guide while Lani Desaulniers patiently awaits the printed guide for distribution by her committee.

The APD Forward Coalition expressed interest in participating in the selection process for a new APD Chief by Mayor Keller following the national search for a new Chief to replace Police Chief Geier who is retiring. Recent coalition meetings with the City of Albuquerque Accountability and Oversight Division (reporting to the Mayor) and the Civilian Police Oversight Agency (selected by the City Council) seek a more comprehensive understanding of the minimal improvement by APD line management of discipline of officers when investigation results indicate Excessive Use of Force.



WOMEN'S RIGHT TO VOTE TIMELINE



1920 NM legislature approves the 19th Amendment on February 21, 1920, 32nd of 36 states necessary for ratification. August 26, 1920 is the official certification date in the US Constitution. NM women are among the 27 million women able to vote in November elections.

1919 Carrie Chapman Catt, president of the National American Woman Suffrage Association (NAWSA), persuades President Wilson to support woman's suffrage, using women's contributions to

World War I as rationale. Congress passes 19th Amendment, 41 years after it was introduced and sends to the states for ratification.

1917-1918 Suffragists are arrested and imprisoned for picketing the White House and the Capitol. Hunger strikes and force-feeding in jail cause national outcry.

1915-1916 Suffragists in Santa Fe organize 150 women in an automobile parade to Senator Thomas Catron's home. He opposes suffrage. Julia Brown Asplund, president of the NM Federation of Women's Clubs, Aurora Lucero, and other women speak about breadth of support for suffrage in NM. NM suffragists organize state chapter of the Congressional Union's National Woman's Party, formed by Alice Paul. Nina Otero-Warren becomes a suffrage leader.

1910 NM Constitution required for statehood is ratified. Full suffrage for women is rejected. A provision that grants women the right to vote in school elections contains a caveat that their vote can be revoked if a percentage of county male voters disagree.



1890s Suffrage clubs are formed in several NM towns.

1878 Woman Suffrage Amendment is first introduced into US Congress at the behest of Susan B. Anthony, who voted illegally in 1872.

1848 First Women's Rights Convention, held in Seneca Falls, NY, passes resolution calling for

full voting rights for women. Elizabeth Cady Stanton authors the Declaration of Sentiments, modeled on the Declaration of Independence, which excludes women.

Greetings Voter Registration Agents:

The Bernalillo County Clerk's Office needs to hire 21 individuals who can assist us as Same Day Voter Registration (SDR) Agents at 7 Early Voting Convenience Centers during the 2020 General Election. You have been selected to be early recruits for this effort because you have attended a Voter Registration Agent training and have a basic understanding of New Mexico voter registration law.

We want to share with you some of the details about this job opportunity:

7 EARLY VOTING CONVENIENCE CENTERS:

- We must hire one SDR Site Agent per site.
- You must be able to commit to working a nine-hour shift every day from Saturday, Oct.
 17 through Saturday, Oct. 31. (Early Voting Convenience Centers are closed on Sundays.)

TO BE HIRED:

- A background check and drug test will be administered by the Bernalillo County Clerk's temporary hiring agency, ITSQuest.
- Training is mandatory. SDR Agents will be paid for training on Friday, Oct. 16, 2020. Time and location for this training will be forthcoming. SDR Agents will receive training pay, provided they show up to work at their assigned location.

ASSIGNMENTS:

- The Clerk's Office will attempt to assign Site Agents to locations nearest to their homes.
- Backup SDR Agents will be assigned to work Downtown (in daily 4.5-hour increments Monday through Saturday). These Backup Agents will be utilized as substitutes to Site Agents and to perform other Voter Registration duties. Our Downtown Office is at 1 Civic Plaza on the 6th floor.

COMPENSATION:

- The work is \$12 an hour.
- If assigned to the Downtown location, the temporary hiring agency reimburses an employee \$2.00 per day maximum for parking. (SDR Agents are responsible for submitting parking receipts directly to the agency at the end of their assignments.)



MaryEllen Smith encourages Voter Registrars to help the County by responding to the above advertisement for help. Poll workers are also needed in Bernalillo and Sandoval County. Apply with Bernalillo County at https://www.bernco.gov/clerk/poll-officials.aspx. In Sandoval County call the Sandoval County Bureau of Elections at 505-

867-7577. In Valencia County, call the Clerk's office at (505) 866-2080. You must be registered to vote in the county in which you want to work. BUT remind all your children and grandchildren that 16 and 17 year olds can be student poll workers. Great training for future voters.

ABSENTEE BALLOTS WILL BE SENT OUT TO VOTERS STARTING OCTOBER 6. DON'T FOR-GET TO VOTE. IF YOU MAIL YOUR ABSENTEE BALLOT BACK TO THE COUNTY CLERK, AL-LOW ENOUGH TIME IN CASE OF POSTAL DELAYS. REMEMBER TO FOLLOW THE IN-STRUCTIONS FOR RETURNING YOUR BALLOT.





ment: picket signs, flowers, and women in white marching through the streets, but demonstrates how much more there was to the movement. Ever courageous and creative, suffragists also carried their cause into America's



homes through cookbooks and food. Suffragists reached out to women on their own terms, in nonthreatening and accessible ways, and thorough those women to the men who held the key to their quest for the right to vote. Using charm and wit, the suffragists leveraged their domestic knowledge and used social situations to put people at ease, pioneering grassroots tactics that fed spoonfuls of suffrage to communities through unexpected and unassuming channels. Filled with actual historic recipes ("mix the crust with tact and velvet gloves, using no sarcasm, especially with the upper crust") and the spirited flavor of feminism and food movements of the suffrage era, All Stirred Up carries us back in time. It then celebrates the suffragists anew with modern adaptations of their recipes and stories of how they changed our lives and our world.

Long before women had the vote, they enfranchised themselves through the subversive – and savvy – power of the palate. They won supporters over with recipes from hot cross buns, fish

chowder, and spatchcock chicken, to roll jelly cake and brownies. Celebrate them and make a dish or an entire meal from their cookbooks!" (From the author's website: Laurakumin.com)

Here is an excerpt: "It also speaks to how in some circles, suffrage was the lightning-rod women's issue of its time, much like abortion is today. The elite: Maud Nathan lent her societal influence to the suffrage movement.

"You see these stunning divides even within families," says Nadell. "My favorite characters were Maud Nathan [pictured to the right] and Annie Nathan Meyer, the founder of Barnard College, two sisters of the elite Nathan family." How elite? Maud Nathan was a card-carrying member of the Daughters of the American Revolution, tracing their ancestry to the Colonial era. Their cousins included "New Colossus" poet Emma Lazarus and Supreme Court Justice Benjamin Cardozo.

"And they hated each other," Klapper says of the Nathan sisters. "One was for suffrage and the other was like, 'Not me!' " The activist Maud Nathan lobbied Presidents Theodore Roosevelt and Wilson and led rallies on behalf of the women's vote, while Meyer countered what she called Nathan's "utterly abhorrent" and "noisy" efforts with anti-suffrage speeches at Barnard. Like many elites, Meyer was skeptical about extending the vote to working-class immigrant women. "But then, as soon as she got the right, she became involved with the League of Women Voters," notes Klapper.
