

# LWVCNM President's Report Donna Sandoval, President and Treasurer


#### LWVCNM BOARD RETREAT

Speaker: Dr. Timothy Krebs



Our October speaker, Dr. Timothy Krebs, is a professor of Political Science at the University of New Mexico. His research focuses on urban elections and policy, and he teaches courses in state and urban policy, campaigns and elections, and state politics. Dr. Krebs will discuss the importance of the upcoming municipal elections.

Dr. Krebs earned his B.A. at Loyola Marymount University and M.A. and Ph.D. at Loyola University Chicago. In addition to research and teaching, Dr. Krebs has held administrative and service positions including seven years as Chair of the UNM Department of Political Science. He currently serves as the Political Science Department's Internship Coordinator. Dr. Krebs is co-author of *Understanding Urban Politics: Institutions, Representation, and Policies*, and he has published over two dozen peer-reviewed articles and book chapters on women and local politics, city council representation, urban

elections and campaigns, and institutional reform in state government. He received the Thornburg Foundation Good Government Reform Grant in Fall 2019 and Best Dissertation Award, given by the Urban Politics Section of the American Political Science Association. Dr. Krebs is the father of two wonderful teenagers, and a huge Dodgers fan!

The October Program meeting will also include a brief update on a General Obligation (GO) Bond issue on the November ballot from Olivia Padilla-Jackson VP of Finance and Operations from Central New Mexico Community College (CNM). Ms. Padilla-Jackson will provide an update on CNM and will provide election details. She will be available to answer any questions regarding CNM or the GO Bond election.

#### Chamber of Commerce Civics Bee - Linda Miller and Judith Binder

The New Mexico Statewide Civics Bee took place in Albuquerque at the UNM Student Union Building on August 19, 2023. The nationwide Civics Bee was introduced two years ago by the U.S. Chamber of Commerce to encourage young Americans in middle school grades to engage in civics and contribute to their communities.



The format includes a 500-word essay describing a community problem and suggesting ways to solve it. It is followed by an in-person competition for the finalists similar to the well-known Spelling Bee. The New Mexico Civics Bee was sponsored by the New Mexico Chamber of Commerce. There were numerous political figures in the audience including the Lieutenant Governor, several state and school board representatives. trustees. LWVCNM members Liz Shields, Judith Binder, and Linda Miller attended.

The participants, who were New Mexico students in middle school in 2022, had submitted essays on using civics to solve a problem in their community, and were selected as the ten finalists statewide. Topics included sexual violence, bullying, safer communities, improvements to parks, and homelessness.

The participants, and the audience along with them, answered two rounds of questions about government structure and the constitution. The quiz was online; the students used tablets to record their answers, and the audience used their phones. The questions were difficult. The five students who had the highest scores were asked to give a three-minute speech about their essays and then responded to questions from the three judges. First place was awarded to Auburn Eichers from Rio Rancho, second place went to Victoria Miller from Aztec, and third place went to Esha Shivashankar from Roswell.

This was an enjoyable and worthwhile experience. We recommend attending again next year.

### **UPDATE ON THE NOVEMBER 2023 VOTE411 / VOTER GUIDE PROJECT**

The nonpartisan Local and Municipal Elections will be held on November 7<sup>th</sup>. The LWVCNM is hard at work to bring information on candidates and other issues on the ballot to voters in our four-county area. This is the first time that we have prepared Voter Guide material for municipal elections in Sandoval, Torrance, and Valencia Counties in addition to Bernalillo County. Teams of League volunteers have gathered information about the races, candidates, and bond questions that will appear on ballots from a wide variety of sources, and we are in the process of entering these data into an online system.

We use LWVUS software, called VOTE411, to send requests to all candidates to answer questions about their priorities and views on issues relevant to voters. Candidate responses will be available to voters in two ways. One way is to use online access through VOTE411.org and enter the voter's address. The voter is taken automatically to the races, candidates, and information on bonds, mill levies, and ballot questions that will appear on her/his ballot. The second way will be to go our website, LWVCNM.org, and view a document similar in format to past printed Voter Guides. Candidate responses to a select set of questions can be read online and downloaded if desired. The website documents will become available when absentee voting begins on October 10.

Note that LWVCNM is not distributing a complete printed Voter Guide this year. The reason is the nature of the election, which is composed of mostly districted nonpartisan races, such as city, town, or village councilors; school board members; supervisors of flood control, soil and water conservation, and water and sanitation districts; small public improvement and tax increment development districts, etc. Each voter's ballot will only have a small number of races. A comprehensive printed Voter Guide is not very useful or practical and wastes a lot of paper.

But rest assured, the printed Voter Guide will be back in 2024!

# Observer Corps Report – Albuquerque City Council meeting 21 August and 6 September 2023 Mary Mulvany/Janet Kirkpatrick

All nine councilors were present at the August 21, 2023 and the September 6, 2023 meetings: Louie Sanchez – District 1, Isaac Benton – District 2, Klarissa Peña – District 3, Brook Bassan – District 4, Dan Lewis – District 5, Pat Davis – District 6, Tammy Fiebelkorn – District 7, Trudy Jones – District 8, Renée Grout, District 9.

#### Short-term rental ordinance (O-23-69)

At the September 6 meeting the council rejected a proposed change to the short-term rental ordinance by a vote of three in favor (Fiebelkorn, Davis, Benton) to six opposed (Bassan, Lewis, Sanchez, Grout, Jones, Peña). The proposed ordinance change would have made short term rental permits available only to natural born persons, as opposed to a business entity. It would also have limited the total number of short-term rentals in Albuquerque to 1200. A less restrictive floor substitution was also voted down.

Public commenters on this issue pointed out that there is a lack of enforcement of the existing registration and permit requirements.

**Opioid settlement funding**. Discussion of an amendment to resolution (R-23-121) at the August 21 meeting demonstrated councilors' concern about the best use of opioid settlement money. R-23-121 is a resolution directing the Albuquerque Family and Community Services (FCS) to enter into a memorandum of understanding (MOU) with Bernalillo County to allocate funds to the Metropolitan Detention Center for opioid treatment and recovery. An amendment to this resolution called for designation of the remaining money to Gateway Center for opioid treatment.

Councilor Bassan expressed concern about designating money to the Gateway Center for opioid treatment before the Gateway's sobering center is operational. The administration estimates it will be operational at the beginning of next year.

Councilor Fiebelkorn expressed concern about designating money to various programs prior to any kind of comprehensive plan is in place to deal with the community's opioid problems. FCS Division of Behavioral Health and Wellness Deputy Director Ramirez shared that a contract is in place with the Health Equity Council to conduct a community needs health assessment. The assessment report is due September 30. DD Ramirez participated in a Behavioral Health Initiative (BHI) working group with Bernalillo County and facilitated communication between the Health Equity Council and BHI to ensure BHI's input is included in the report.

Councilors Grout and Jones agreed with the need for a comprehensive community-wide plan.

The amendment failed on a 1-8 vote, with Councilor Peña the only vote in favor.

The council postponed vote on R-23-121.

**Neon tumbleweed**. During the August 21 question and answer period Councilor Grout asked whether a neon tumbleweed planned for the Rail Trail had gone through the public art approval process. The City's Department of Municipal Development representative stated the Rail Trail neon tumbleweed is in the conceptual design phase and has not gone through the public art approval process. Other art on the Rail Trail will go through the public art process. Councilor Grout stated she has heard from constituents who disapprove of the design and she would like to see the concept reconsidered.

#### **Public Comment**

Nine of 19 audience members who made public comment advocated to limit voting through "cleaning up" County voter rolls, replacing electronic voting systems and machine tabulation with paper ballots and hand counting, eliminating centralized tabulation centers, eliminating MVD and same-day voter registration, requiring voter IDs, and prohibiting voter registration within 30 days prior to an election.

#### Commissioners Discussion

The Chair announced that the Deputy County Manager is working with others to ensure that freeroaming horses of Placitas are fed while the County adjusts its original strategy that relied on nonprofit organizations for this.

#### **Bernalillo County Commission Struggles with Transparency**

The Bernalillo County Commission has proposed two revisions to the Transparency Portal. In my last report I discussed the revisions. Subsequently we sent this letter, approved by the board to the commissioners.

September 11, 2023

Dear Commissioner Baca.

The League of Women Voters of Central New Mexico has some concern over proposed changes to the Bernalillo County Transparency Portal Ordinance. We are particularly concerned about the proposed addition of a sentence to section 3.

That sentence reads. "Contracts which could compromise the safety and security of the County will not be included in the contract listing." During the oral presentation of the proposed ordinance change there was no mention about why the county is seeking the change. On the welcoming page of BERNCO VIEW, the County's official Transparency Portal, its stated purpose is "...to bring better visibility, openness and accountability to county government." How would citizens know that a contract has been entered into if the contract is not listed on the portal. It is also not clear how this would be a benefit to the county.

We would like to urge the county commission to consider a way to list all contracts the county enters into on the Transparency Portal. If there is a specific reason to shield some information about a particular contract, the general purpose of the contract, the reason should be stated, and instructions for making an Inspection of Public Records Request, such as a link to the formal form, should be placed in the Transparency Portal. The language that "contracts which could compromise the security and safety of the County" is too vague to be useful, and appears to be antithetical to the spirit and purpose of the ordinance.

Voters need the opportunity to see and understand the public business of Bernalillo County.

### Observer Corps Report – Update for City of Albuquerque Mental Health Response Advisory Committee (MHRAC)

#### **Lani Desaulniers**

Open public meetings are held monthly (currently on Zoom). Meeting links, with the agenda and minutes are posted on the MHRAC website.

Updates from the July 18, 2023 meeting included:

 Dr. Peter Vielehr, Director of Analytics from APD, presented a detailed summary of contacts for Behavioral Health Incidents provided by the Crisis Intervention Team (CIT) in 2022. During the course of the year, more calls were diverted to ACS. A detailed review of CIT calls that resulted in use of force was provided. Updates from the August 15, 2023 meeting included:

- Smart 911 Service: Albuquerque has initiated a contract with a company (<u>Smart911</u>) which
  allows residents to enter information into a database (linked to their phone number) that is
  accessible to dispatch operators when a 911 call is made. Information is otherwise stored in a
  secure database. Any information provided is completely voluntary, but could include
  information about a person's disability (hearing, vision, intellectual), psychiatric diagnosis,
  advanced directives, etc. that might be helpful to first responders.
- Albuquerque Community Safety (ACS) Report:
  - The department plans to roll out 24/7 services beginning on August 26th. Staff working the night shifts will be equipped with reflective vests, additional lighting sources, as well as emergency lighting for themselves and their vehicles.
  - ACS received notice last week they have been awarded a 2-million-dollar Department of Justice Discretionary Project Grant to support their work.
- <u>Gateway Center at Gibson Health Hub:</u> The 50 residential bed unit for women has now officially opened. They will be providing comprehensive services to these individuals on site with the overall goal of helping them find a stable housing situation.









# Observer Corps Report - APS Board of Education meetings 19 July, 2 and 16 August, 6 September 2023 Laura J. Downing

I "attend" the YouTube live stream of the meetings, and I report on topics most relevant to LWVCNM policy positions.

**Public Forum.** The public forum was lightly attended over the summer. Important themes were: several parents expressed support for bilingual education and, specifically, the bilingual program at Washington Middle School which some feared was threatened by a proposed expansion of the Coronado magnet school. Concern was expressed for staffing shortages, such as a lack of special education teachers and teachers for the dual language programs. Members of so-called parents' rights groups (<a href="https://www.weareteachers.com/parents-rights-opinion/">https://www.weareteachers.com/parents-rights-opinion/</a>) continue to attend regularly and falsely accuse APS teachers and counselors of promoting abortions, transgender care, gender identity to even young students, without the knowledge or consent of parents. As noted in previous reports, this is a national movement, and the local group seems to be well organized, since the public forum participants at each meeting seem to come with similar information and sources for their accusations (none of them seem to be referring to actual incidents at any APS school).

The Board meetings proper continued to be dominated by detailed discussions implementing the strategic five-year plan for APS in order to satisfy the settlement requirements of the Yazzie-Martinez lawsuit, which addressed inequities faced by certain groups of students – in fact, the vast majority of students – in the New Mexico public school system: <a href="https://webnew.ped.state.nm.us/bureaus/yazzie-martinez-updates/">https://webnew.ped.state.nm.us/bureaus/yazzie-martinez-updates/</a>. One effect of the new Student Outcomes Focused Governance approach that informs the five-year plan is that the Board is monitoring things like attendance and testing results regularly, holding the Superintendent's office to account to provide data in a much more systematic and transparent way. More information about reports and goals the Board is monitoring during the meetings is now included on the APS website where the Board meeting schedule is listed. Regular community listening sessions are now on the Board's schedule so that the community should be playing more of a role in decision making.

Given the current staffing shortage for teachers and other school staff, it is important to note that two items came up for approval that might help to improve that situation: the teachers' union's new agreement with APS, which improves salaries and working conditions for teachers, and an updated health insurance proposal. These two proposals were passed nearly unanimously, except that one Board member did not approve the union's proposal and presented a lengthy statement to motivate her decision.
