

TOPIC: "The Impact of Artificial Intelligence on the 2024 Election"

SPEAKERS: Professor Huiping Cao, NMSU Department of Computer Science.

Artificial Intelligence (AI) has infiltrated every aspect of our online activities including the composition of educational articles, search for items and information, discussion of purchase options, and consideration of choices for lifestyle, education, and employment. Residents should anticipate that AI is also impacting our 2024 election outcomes by shaping our opinions and promoting selective data and facts. Information searches reliably offer related subjects from other resources and promote specific references which may alter or reinforce our beliefs and expectations.

Our October LWVCNM educational meeting, "The Impact of Artificial Intelligence on the 2024 Election" presented by Professor Huiping Cao, NMSU Department of Computer Science, will explore these concerns and indicate which decisions could most easily be altered by AI and those most resilient in the face of propaganda or distractions.



Professor Cao obtained her Ph.D. from the Department of Computer Science at The University of Hong Kong (HKU) in 2007 and her master's and bachelor's degrees from the School of Information at Renmin University of China (RUC) in 2002 and 1999, respectively. Her research interests are in the general areas of data mining, applied machine learning, and databases. In particular, she works on creating effective and efficient computational methodologies for the discovery of useful knowledge from complex data (e.g., sequences and graphs) through pre-defined mining requests or ad-hoc queries. She is also interested in applying these techniques to analyze data from different domains such as smart grids, animal and range sciences, agriculture, and high-performance computing.






The LWVCNM Book Club meets the 4th Wednesday of each odd-numbered month, except November which is the 3rd Wednesday.

ELECTION UPDATES

The LWVCNM Voter Guide for the November 5th general election can now be viewed using a link from our website: wvcnm.org. The printed *Voter Guide* deliveries are underway. VOTE411.org is expected to go live on October 5.

We will be reaching out to volunteers to assist with delivering the guides to designated sites in the four counties in October. Members are also encouraged to distribute them to friends, family, and local businesses that they frequent. Guides will be available at the LWVCNM office at 6739 Academy NE Suite 124. Please call ahead of time: 505-884-8441 to arrange a time to pick them up.



The LWVNM has registered as an Election Related Organization with the Secretary of State (SOS). This gives us the opportunity to appoint nonpartisan "Watchers," which allows us to be inside voting locations to observe the voting process. This is different from a "Challenger" who can challenge the process.

Press Release from LWVUS - Addressing Racist Attacks in Presidential Debate

The League of Women Voters of Central New Mexico participated in a gathering at Tiguex Park in early September.

The Dignity Not Detention Community Event partnered with immigrant rights organizations across the state to publicize and educate the public on federal ICE detention conditions and injustices, highlighted in the 2023 NM legislative session bill that sought to end civil immigration detention in New Mexico and prohibit ICE contracts with privately-owned prisons such as those in Torrance, Cibola and Otero Counties.

Speakers included elected officials, including the bill's sponsors, Sen. Gerald Ortiz y Pino, D-Albuquerque, and Sen. Antonio "Moe" Maestas, D-Albuquerque

Community groups, including the LWVCNM gathered under a bright NM sky at Tiguex Park for the Dignity Not Detention event.

OBSERVER REPORTS



Observer Corps Report – Albuquerque City Council meeting

19 August / 9 September 2024

All 9 councilors were present at the Aug 19 & Sept 4 meetings: Louie Sanchez – District 1, Joaquin Baca – District 2, Klarissa Peña – District 3, Brook Bassan – District 4, Dan Lewis – District 5, Nichole Rogers – District 6, Tammy Fiebelkorn – District 7, Dan Champine – District 8, Renée Grout, District 9.

General Public Comment Items:

<u>Speaking opportunity limited</u>. Several members of the public mentioned difficulties with signing up online to speak at the August 19 meeting. Mr. Padilla, Director of City Council Services, stated that General Public Comment was limited to 30 speakers.

Albuquerque Minimum Wage Ordinance

At a previous council meeting Councilor Grout proposed an amendment to the Albuquerque Minimum Wage Ordinance to reduce the city's minimum wage for tipped employees to \$3. The Albuquerque Minimum Wage Ordinance was proposed by Councilor Rogers on behalf of the city administration. Decision on the ordinance was deferred to the August 19th meeting. However, prior to this August 19th meeting, Councilors Grout and Bassan issued a press release stating they were withdrawing the \$3 tipped employee minimum wage amendment. In addition to setting minimum wage, the ordinance provided for the city to investigate wage theft claims.

Despite the withdrawal of the \$3 tipped employee minimum wage amendment, 29 people spoke against the amendment. Several speakers cited incidents of wage theft.

Councilor Bassan commented that our city has "much bigger fish to fry when it comes to crime and problems" than to enforce wage theft laws by "going after hardworking business owners." See her comments at the 4-hour 25-minute mark of the video. 8.19.24 Council Video

Other councilors asked for clarification and expressed that the bill needs to be fine-tuned. They also discussed whether the city's enforcement of wage theft duplicates efforts by the State. Councilor Grout apologized to anyone she may have offended in proposing the \$3 minimum and stressed that she does not want to take wages away from anyone.

The Albuquerque Minimum Wage Ordinance failed by a vote of three in favor (Baca, Fiebelkorn, Rogers) to six opposed (Bassan, Champine, Grout, Lewis, Peña, Sanchez).

Balloon Fiesta/Soccer Stadium Appeal Denied

Several neighborhood associations and neighbors of Balloon Fiesta Park had appealed the Environmental Planning Commission's decision to advance development of seven acres of the park for the soccer stadium. At the August 19th meeting the council voted to deny the appeal. Although they denied the appeal, they agreed that additional traffic mitigation measures must be taken.

Development of the soccer stadium will proceed. Eight councilors voted to deny the appeal, with one voting in support of the appeal (Bassan). AC-24-15

Affordable Housing

At the September 4 meeting, the city council voted unanimously to pass redevelopment tax abatements on three affordable housing projects:

<u>R-24-75</u> Park Central Apartments developed by Route 66 Multifamily LLC. The project converts an office tower, located at 300 San Mateo Blvd NE, into 101 apartments.

<u>R-24-76</u> Somos Affordable Housing project developed by SOL Housing. This 70-unit multi-family project is located at 7200 Central Ave SE.

<u>R-24-78</u> Garfield Townhomes project developed by Garfield Townhomes LLC and Sunlight Properties LLC. This project adds 16 units at 2404 Garfield Ave SE.



Observer Corps Report – Bernalillo County Commission September 2024

Bernalillo County Commission Approves Tax Exemption for Film Studio

The Bernalillo County Commission has endorsed a \$186 million Industrial Revenue Bond to Mesa Film Studios. The IRB will exempt the studio from property taxes for 30 years. The city of Albuquerque owns the land north of Double Eagle Airport that the company plans to lease. Negotiations are underway with neighborhood associations, nearby tribal governments and the City of Albuquerque about the height of the proposed buildings for the studio. The company plans to build six sound stages and oversized million and 60-thousand square feet of office space. Company representatives say there will be 48 fulltime jobs associated with the studio.

The Bernalillo County Clerk's office received \$2.2 million dollars for expenses related to the November general election.

The commission also approved a 6.5% increase in solid waste fees, and accepted grants from the state of New Mexico to assist in hiring more officers for the Metropolitan Detention Center and the Youth Services Center.

It also approved \$3.8 million dollars to the Albuquerque Bernalillo County Water Utility Authority to design a sewage system for Carnuel, an unincorporated land grant community in the east mountain area.

Description of Issues Relevant to the League

Affordable Housing

The Commission approved two HUD Continuum of Care agreements that provide \$356,000 in rental assistance.

As background:

LWVNM supports efforts to increase the availability of safe, decent, and affordable housing for moderate and low-income households through actions that include public and private partnerships and grants, developmental agreements, rehabilitation, fee waivers, density bonuses, and an affordable housing trust fund and land bank.

Additional Comments

Public Comment

Five of thirteen speakers expressed gratitude for Commission support of the Mesa Club and Desert Mountain Healing – two organizations that assist people in addiction recovery. Another five speakers presented an alternative US history and asserted that the only functions of government should be punishment and defense against invaders.

Commissioner Discussion

In response to public comment that the Commission has never taken action on a proposal from the public, the Chair then listed several proposals acted upon, including reducing the number of voter drop boxes in the County from seven to two.

Affordable Housing Report -- Middle Rio Grande Housing Collaborative (MRGHC) Update

The MRGHC met on Thursday, August 22, 2024 after a 3 month hiatus from their last meeting on May 9, 2024. In the interim, Serg Martinez, one of the original MRGHC members had resigned and was replaced by Steve Anaya. The following MRGHC members were present at the August meeting: Talia Friedman, Dan Majewski, Lawrence Rael, Ian Robertson and Steve Anaya. The Interim Chair, Talia Friedman asked for nominations for Officers for the MRGHC and the following persons were elected: Talia Friedman, President; Dan Majewski, Vice-Chair; and Ian Robertson, Secretary.

Updates and Action Items: The Middle Rio Grande Council of Governments (MRCOG) has agreed to be the Fiscal Agent for the MRGHC and a draft agreement is being finalized. The MRGHC finalized and approved the Executive Director position job description as an action item. It was also agreed that the MRCOG will be the official hiring entity for the MRGHC Executive Director but the City and County Human Resources Departments will be responsible for collaboratively advertising the position. The MRCOG will provide office space for the Executive Director.

Also, at the August meeting Lawrence Rael was instrumental in encouraging the MRGHC to get prepared to make fiscal/grant requests for affordable housing development at the 2025 New Mexico Legislative Session. The MRGHC members discussed the desire to request an allocation of affordable housing development funds which would then be released via Request for Information (RFI). The intent is to use the State funds as leverage to extend financial support across numerous new and rehabilitated multi-family construction projects. Both the City and County staff will be asked to submit proposed multi-family affordable housing projects by November 15, 2024.

At its next meeting on Thursday, September 26, 3:00pm @ MRCOG, the MRGHC will be seeking more information and education about affordable housing development processes, so they have invited Joseph Montoya, Deputy Director of Housing, of the City of Albuquerque's Health, Housing and Homelessness Department, to make a presentation at the meeting.
