The 2025 NM Legislative session is in the books. Friday, April 11th was the Governor's last day to sign and line-item veto bills. We owe three of our members, Jeanne Logsdon, Dick Mason, and Janie McGuigan a huge thank you for the work they did during the session. Some of the wins; SB16 – Non-Major Party Voters in Primary Elections, SB 37 - Strategic Water Reserve fund, SB 1 and SB 3a – Behavioral Health, SB267 – Housing Application Fees, SB 36 – Sensitive Personal Information Nondisclosure, and increasing Educational Salaries. 

2025 Recap of Proposed and Enacted Housing Legislation in the 2025 Legislative session

Housing Needs in NM

Ensuring affordable housing options for people of all income levels is crucial for a well-functioning economy. That said New Mexico is facing an unprecedented housing shortage and related affordability crisis. Since 2017 New Mexico has seen homelessness increase 87%, 47% faster than the national average. Median rents in New Mexico have increased 60% in that same time, as compared to 27% nationally. Advocating for more housing units to be built or rehabbed in New Mexico (whether multi family or single family) will ultimately place more housing units in the market, ease the housing shortage and bring down rents for low to moderate income households.

Advocacy at the 2025 Legislative Session

Each Legislative Session the LWVNM establishes priority areas to track legislation and concentrate its lobbying efforts on. For the 2025 Session, Housing was designated as one of the four Legislative Priority groups – the other priority areas were: Environment, Health Care Priority and Voting, Elections & Ethics. Each priority group formed a subcommittee that tracked legislation. The members of the Housing Priority group were Starlyn Brown, Janie McGuigan, Karen Wentworth (all with LWVCNM) and Elizabeth Bardwell (LWVSNM).

Overview of Proposed Housing Legislation

This session saw a significant increase in housing legislation introduced. Over 200 bills sought to address a wide variety of housing needs and issues including: funds for the development of new and/or rehabilitated housing (SB145 Housing Trust Fund); legislation to create a new State Office of Housing Planning and Production (SB205/HB448); and, incentives for municipalities to implement land use and zoning strategies that increase housing affordability and accessibility (HB571 Building Communities Act). Most notable was the extent of legislation introduced to address the landlord –

tenant contractual relationship. There were bills introduced to address the terms of rental applications, screening of tenants, allowable income streams, background and screening processes as well as adequate notices of fee and rent increases, e.g. SB267 (Housing Application Fees and Tenant Protections), HB43 (Housing Income to Rent Screening Calculations), HB98 (Automatic Expungement of Eviction Records), HB462 (Nonpayment of Rent Notice Period), HB253 (Sealing of Certain Court Records), HB339 (Preventing Housing Discrimination based on a Housing Applicant's Source of Income), and HB462 (Nonpayment of Rent Notice Period).

Advocating for Changes in LWVNM Housing Position

Noting these changes in the landscape of housing needs to ensure access to affordable rental housing, the Housing Priority group researched other LWV Housing positions across the U.S. and advocated for the adoption of this statement in the LWVNM Housing position: '*Protection of the rights of both tenants and landlords*' from the LWV State of California, Housing Position. This change and other amendments to the State position include: encouraging energy efficient building electrification; promoting developments that provide a mix of market rate and affordable housing units; and, supporting homeless programs that provide both shelter and services for targeted populations – and were submitted and accepted by concurrence by the LWVNM Board midway through the Session. These changes allowed housing advocacy work during the latter part of the 2025 Session to include a broader array of housing needs in its advocacy portfolio.

Update – at the LWVNM Convention April 26 – 29, concurrence with the proposed LWVNM Housing position updates passed by unanimous vote.

The Final Outcome

In the final analysis, two housing-related bills passed the House and Senate and were sent to the Governor's office for signature. **SB267**, Housing Application Fees and Tenant Protections, which caps late fees and application fees and requires adequate notice of any changes in fee structure, was signed by the Governor on April 8; and, **HB571**, Building Communities Act, which creates incentives for municipalities that reform their zoning codes to promote the construction of affordable housing, was pocket vetoed. The rest of the housing bills died in either the Senate Judiciary Committee, respectively. Creating more affordable housing to ease the impact on the housing market and remove barriers for unhoused persons is a daunting challenge. It is important that we continue to advocate for the development of, and equal access to, affordable housing.

OBSERVER REPORTS



Observer Corps Report – Bernalillo County Commission March/April 2025 Karen Wentworth

The Bernalillo County Commission is focused on providing Industrial Revenue Bonds for companies planning to expand and purchase equipment for use in the county:

• 3D Glass Solutions, \$30 million in IRB

Taxable Revenue Bonds

Public Service Company of New Mexico, \$225 million
For a battery energy storage system on the Pajarito Mesa next to the PNM substation.

The Observer Committee is closely following public financial commitments for housing. The commission has approved both market rate and affordable housing bonds.

- Taxable IRB, \$15,700,000. for Sawmill mixed use retail and commercial space, with 140 market rate apartments.
- Taxable IRB \$70,400,000 for improvements and real property for Chaco Residences.
- Taxable IRB, \$76,300,000 for Sawmill Project Hotel. Five-story hotel with 115 guest rooms and commercial space.

Project Revenue Bonds for Affordable Housing Projects in cooperation with the Albuquerque Housing Authority

The BCC approved \$16,500,000 for rehabilitating an existing 42-unit public housing property and to construct an additional 46 units in the Central/Coors Blvd. area. The units currently house 175 people. Construction will allow for 366 new residents.

The commission also approved the annual application to the U.S. Department of Housing and Urban Development. The money the county received this year allowed it to provide 4,000 housing vouchers for short term stays in hotels and rental units for people in need. It is not clear whether the grant money will be available this year, because the Trump administration has announced plans to cut the program.

Speed Cameras

The county intends to increase the number of speed cameras on major roadways. Currently 7 of the 11 cameras are located in the Southwest portion of the city along Coors Blvd. Commissioner Olivas voiced concerned that the cameras are primarily located in minority areas and was told the cameras are located in areas of the most serious automobile crashes.

Description of Issues Relevant to the League

Transparency in State and Local Governments

The Commission discussed the status of IPRA in Sandoval County currently, after a member of the public proposed that an IPRA task force be formed. Some counties are addressing a request backlog, as well as sorting out what kinds of information are confidential and cannot be disclosed. The county attorney cited an example of a large load on the county coming from only a few requestors, such as Lexus/Nexus, a larger corporation based in London which requests IPRA data for their research and then sells it for profit. Several state bills were introduced to provide protections for various similar circumstances. IPRA is an unfunded mandate at the county level.

As background:

LWVCNM expects all state and local governments, executive and legislative, to follow the requirements of the Inspection of Public Records Act (IPRA).

Public Comment

Two of 7 speakers expressed concerns about funding to properly staff the new animal shelter under construction. Two other speakers promoted a rewritten early US history.
